Park and Landscaping Improvements -the approved improvements are on hold due to the storm and clean up.

ARC Fence and Cabana violation - The fence at 9512 Chelford has not been removed and the ARC approval for the cabana is still open due to there being no permit.

A Motion was made to impose fines of \$100 per day up to \$1,000 subject to a fine hearing.

New Business

Hurricane Damage - The Board thanked the volunteers for cleaning up the debris from the park. There was also a discussion on whether to clear the streets and fund this but an assessment which could be covered by the individuals' insurance for loss assessment, or wait until the County does it. Jim Farese mentioned he was at a County Meeting with commissioner Andy Solis and that it could take months to clear all debris. Owners are encouraged to write the Commissioner and ask for some priority.
